The undersigned understand that the scope of the evaluation and requested reports may include, but is not limited to, the following areas: verification of current and previous residences, employment history, character references, credit history and consumer reports, criminal history records from any criminal justice agency in any or all federal, state, county jurisdictions, birth records and any other public records, and interviews with third parties relative to the undersigned’s character and general reputation in the community. The undersigned hereby release and agree to indemnify, defend and hold harmless Linx of Lake Mary, LLC (“Club Operator”), the Links of Lake Mary, and any management firm retained to operate the Facilities on a day-to-day basis, and their directors, officers, shareholders, partners, managers, members, employees, affiliates, representatives, agents, heirs, successors and assigns and the family members of each of them, from any and all liability for damages of whatever kind, in connection with investigating the undersigned's qualifications for membership at the Links of Lake Mary.
